SECTION A - SUPPLEMENTAL INFORMATION

PROGRAM: Stryker Armored Vehicles Program

1. This Modification B3 to Delivery Order 0002 under Contract DAAE07-00-D-M051 is a unilateral action.
2. Modification 73 to Delivery Order 0002, a unilateral change order modification, was executed on 29 August 2002. Modification 73 authorized a level of effort (under Sub-CLIN 9005AB) for the engineering design analysis to develop an installation kit for augmentation of the Stryker Infantry Carrier Vehicle (ICV) into a Company Commander's Vehicle.
3. The purpose of this Modification B3 is to delete a design requirement contained in Modification 73. Modification 73, Section A narrative, Paragraph 3f stated "Add a FHMUX for the AN/VRC-92F SINCGARS radios and include an additional line to the AN/VRC-90F for future use." This Modification B3 deletes the portion of that requirement as follows: "and include an additional line to the AN/VRC-90F for future use." Except for this minor change, all other Sub-CLIN 9005AB requirements remain as stated in Modification 73.
4. As a result of this Modification B3, the price of Delivery Order 0002 is neither increased nor decreased. Except as specifically stated above, all other terms and conditions of the Contract and Delivery Order 0002 remain unchanged and in full force and effect.
